



## **Frenectomy Insurance Policy and Fee Schedule**

A frenectomy is a procedure that consists of releasing the frenum under the tongue, upper lip, or cheek to allow for better range of motion. The procedure is performed to allow for the tongue and/or the lip to function properly during feeding and to promote proper growth and development of the craniofacial complex.

Our office does NOT accept any form of dental insurance or medical insurance for payment or reimbursement. We are a **strict fee-for-service office** and all fees are due the same day as the appointment.

Insurance coverage for this procedure should be processed from your dental and/or medical insurance policy. If this procedure is covered under your dental or medical insurance plan, you (the subscriber) will need to submit the claim and pursue reimbursement directly from the insurer. Dr. Joanna Green is **not** an in-network provider with dental or medical insurances.

**Our office will supply all clinical documentation upon request.**

*There are three ways you could possibly get reimbursement from your insurance carrier:*

- 1) Child's dental insurance policy. Parents will typically need to add the child to policy.
- 2) Mother's medical insurance policy. Typically, the procedure must be performed in the first 30 days of life while the infant is still covered under the mother's policy, if this option is used.
- 3) Child's medical insurance policy.

**\*\* Most insurances will require **Prior Authorization / Predetermination**.** Contact your insurance provider prior to having the procedure completed, use the codes on the next page.

Fees for frenectomy treatment are due in full at the time of service. We accept Credit Cards, Debit Cards, HSA Cards and cash.

The each procedure/site is \$549.

For example: Lingual or labial frenectomy is \$549  
Lingual and labial frenectomy is \$1098.

We do not charge additional for buccal frenectomies.

**Here is some information that you may need while seeking coverage information:**

**Dental Insurance Codes for Reimbursement: ADA Codes**

D7961 - Buccal/Labial Frenectomy

D7962 - Lingual Frenectomy

The code for the frenectomy is the same for the Upper Maxillary Labial Frenulum (UL) and the Lower Mandibular Lingual Frenulum (LL).

Depending on your dental insurance carrier they may require certain descriptive words to differentiate between the arches:

Upper arch (lip tie): (UL or UA)

Lower arch (tongue tie): (LL or LA).

ICD 10 Code: Diagnosis of Restricted Labial Frenulum (Lip Tie) Q38.0

Procedure CPT Code: Lingual or Lower Tongue Frenulum / Frenotomy: 41115
